MINUTES OF THE MEETING OF THE BOARD OF PUBLIC WORKS OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA HELD June 16, 2021

THE BOARD OF PUBLIC WORKS (BPW) OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA, met in regular session on June 16, 2021, at 1600 O Street at the hour of 11:30 a.m. This meeting was held in open session as required by Chapter 84, Article 14 of Nebraska State Statutes.

Chairman Knipe called the meeting to order. Roll call: Member's present – Shaw, Grant, Knipe, Wilson and Zaruba.

Chairman Knipe announced that this was an open meeting, and a copy of the open meetings act is available for review.

Chairman Knipe acknowledged the following guest: Olivia Block – Work in Water Grant-intern.

GM Hunter reviewed the final draft of the Water Risk and Resilience Plan. The plan will be filed with the EPA. Upon approval BPW will update emergency plans to ensure all steps are taken to reduce risks during drought situations. Member Zaruba made a motion to accept the plan as presented. Member Grant seconded the motion. Those voting aye – Grant, Knipe, Wilson, Zaruba, and Shaw. Motion carried.

GM Hunter updated the Board on the 319 Source Water Protection Plan. Customers will be notified of the opportunity to cap abandoned wells and cisterns (within city limits) at no cost. Engineering costs will be covered under a grant. In addition, property owners who currently have septic systems may have their system inspected at no cost. Information will be provided to the public on the importance of septic system maintenance and source water protection. GM Hunter requested approval of the JEO Scope of Service for the project which needs approval to move forward. Member Shaw made a motion to approve the Scope of Service. Member Wilson seconded the motion. Those voting aye – Knipe, Wilson, Zaruba, Shaw, and Grant. Motion carried.

GM Hunter requested approval of the BPW Health Reimbursement Arrangement Plan Document and Summary Plan Description (HRA). The Plan provides information on the HRA portion of the health insurance benefit provided by Mid-American Benefit. Member Grant made a motion to approve the HRA plan. Member Zaruba seconded the motion. Those voting aye – Wilson, Zaruba, Shaw, Grant, and Knipe. Motion carried.

GM Hunter submitted a request from Auburn Development Council (ADC) for a donation. ADC is a private organization and the BPW cannot be a member. BPW does generally provide them with a donation. This funding is used as advertising for economic development. Legislature allows the BPW to contribute to a local organization such as the ADC; if the money is directed to a project in which the BPW itself has authority to engage. Discussion was held. Member Zaruba made a motion to donate \$1200.00 to the ADC. Member Grant seconded the motion. Those voting aye – Zaruba, Shaw, Grant, Knipe, and Wilson. Motion carried.

GM Hunter presented a request from the Auburn Chamber of Commerce (Chamber) for our annual donation. This funding is used as advertising for economic development. Legislature allows the BPW to contribute to a local organization such as the Chamber; if the money is directed to a project in which the BPW itself has authority to engage. After discussion, Member Shaw made a motion to donate \$1000.00 Member Wilson seconded the motion. Those voting aye – Shaw, Grant, Knipe, Wilson, and Zaruba. Motion carried.

GM Hunter provided a request for a progress payment submitted by Empire Trenching Inc., in the amount of \$53,416.80. Work has been completed on wells 13 and started on wells 1 & 2, which were damaged during the 2019 flood. FEMA has provided funding for this project. Member Wilson made a motion to pay the progress payment. Member Zaruba seconded the motion. Those voting aye – Grant, Knipe, Wilson, Zaruba and Shaw. Motion carried.

GM Hunter provided an update on the Transmission line/Substation project. He noted that the Substation and Power plant are in the process of being tested and switched over. He is working with the contractor on items that need to be finished to complete the job. Rock is on order and a solution to prevent rock from being washed out is being discussed. Contract work in the alley will be cleaned up once internet and phone companies have finished their work. No further action.

GM Hunter submitted a progress payment from IES for payment. The request is appropriate for work completed by contractor. Member Zaruba made a motion to submit payment for \$90,462.69. Member Grant seconded the motion. Those voting aye – Wilson, Zaruba, Shaw, Grant, and Knipe. Motion carried.

GM Hunter informed the Board that the Peru water line project is still in process. Engineers are working with Peru on a route. BPW will not be involved with most of the planning, until they are ready to work on the connection to our system. The temporary water treatment facility was down for nine days for maintenance and 679,000 gallons of water was hauled in during that time. A two-inch line burst during the resulting in extra downtime for the temporary site. The site is now running again. No further action.

Members Zaruba and Grant represented the City Administrator/Economic Developer Committee and provided updates on the progress of the position. First round interviews have been conducted and two candidates have been called back for a second round. They noted that multiple entities will be represented in the second round, including BPW, the hospital and the school. The goal is to provide all parties an understanding of future expectations. No further action.

AFM Westhart presented the standard financial reports to the Board. Member Wilson made a motion to accept the financial reports as presented. Member Shaw seconded the motion. Those voting aye – Grant, Knipe, Wilson, Zaruba, and Shaw. Motion carried.

Chairman Knipe asked for any objections or exceptions to the General Consent Items listed under Agenda Item #15.

Approve the previous meeting's minutes and dispense with the reading of the same.

- a) Approve monthly compensation of officers, management, and employees as previously fixed by the Board.
- b) Approve, ratify, and allow the following checks, recommended transfers and claims submitted for payment during the month.
- c) Approval of delinquent water and wastewater accounts.
- d) Approve filing of Notices of Delinquency with the County Clerk.
- e) Transfer funds from E-W-WW Revenue funds into checking for expenses, plus the routine interdepartmental transfers in the amount of \$486,000.00
- f) Approve Free Service Report.
