## MINUTES OF THE MEETING OF THE BOARD OF PUBLIC WORKS OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA HELD JUNE 18, 2025

THE BOARD OF PUBLIC WORKS (BPW) OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA, met in regular session on June 18, 2025, at 1600 O Street at 11:30 a.m. This meeting was held in open session as required by Chapter 84, Article 14 of Nebraska State Statutes.

Chairman Knipe called the meeting to order. Roll call: Members present –Shaw, Grant, Knipe, Wilson, and Zaruba.

Chairman Knipe announced that this was an open meeting, and a copy of the Open Meetings Act is available on the conference table in the Board room.

Chairman Knipe acknowledged the following guests: Maxine Schatz and Jason DeBuhr – both representing the Nemaha County Ag Society.

Chairman Knipe called for election of officers. Member Grant made a motion to nominate Member Knipe as Chairman, Member Wilson as Vice Chairman, and Member Zaruba as Secretary. Member Shaw seconded the motion. After discussion, Members voting aye — Grant, Knipe, Wilson, Zaruba, and Shaw. Motion carried.

Chairman Knipe introduced Jason DeBuhr from the Nemaha County Ag Society. A request was presented to use water for an upcoming Legion Ball tournament and the Nemaha County Fair to be held August 9-13. Water usage for the Nemaha County Fair will be used from the Rotary Park Lake for animal consumption and cleaning as needed. The Board agreed that City water may be used when necessary. No action taken.

General Manager Luhring provided an update on CD's that matured May 26, 2025. Auburn State Bank was awarded the CD's with a 4.00% - 12-month term. No action taken.

General Manager requested authorization to submit for bids on five CD's maturing on July 08,2025. CD's are currently valued at \$2,792,090.90. CD's will be awarded to the highest bidder. Member Zaruba made a motion to submit for bids as presented. Member Shaw seconded the motion. Members voting aye – Zaruba, Shaw, Grant, Knipe, and Wilson. Motion carried.

GM Luhring provided updates on the Westgate addition, noting that the street paving is nearly finished. Electric infrastructure installation will resume upon completion. No action taken.

GM Luhring provided information on the Drought Contingency Stage 3 Water Emergency, noting that there has been little change in the status of our wells. Rain has not been significant and therefore levels have not changed. Water usage continues to remain low due to customer vigilance in conservation. No action taken.

GM Luhring discussed the Long's Creek project as a short-term water source supply. State agencies are currently satisfied with projected plans, which include the installation of a UV treatment process at the Water Treatment Plant. GM Luhring requested authorization to request bids for a UV disinfection treatment system to be installed at the Water Treatment Plant. Member Grant made a motion to request bids upon completion of engineering specifications. Member Zaruba seconded the motion. Member's voting aye – Knipe, Wilson, Zaruba, Shaw, and Grant. Motion carried.

GM Luhring requested approval to enter into a lab proposal agreement with Westech for jar testing water from Longs Creek at a cost of \$3,380.00 per day, plus additional field service cost per day of \$1,600.00, which is not expected to be more than one or two days. Member Shaw made a motion to approve the agreement as presented. Member Wilson seconded the motion. Members voting aye – Wilson, Zaruba, Shaw, Grant, and Knipe. Motion carried.

GM Luhring requested authorization to request bids for a temporary Water Treatment Plant that will treat water extracted from Long's Creek for a short-term water supply. Member Grant made a motion to advertise for bids based on specifications presented. Member Zaruba seconded the motion. Members voting aye – Zaruba, Shaw, Grant, Knipe, and Wilson. Motion carried.

GM Luhring updated the Board on progress of the NPPD Capacity Purchase agreement noting that eight companies are involved in the negotiations. No action taken.

GM Luhring provided updates on progress of the NPPD Wholesale Power contract. No action taken.

GM Luhring provided information on a public outreach open house that will be held at Arbor Manor on June 25<sup>th</sup>. The open house is the first of sixteen across the State of Nebraska that will focus on educating the community of the benefits of being selected as a finalist for a Small Modular Reactor (SMR). No action taken.

Water/Wastewater Manager Slater provided updates on the progress of CO2 cleaning of the wells. Three wells remain and are projected to be finished on Friday June 20, 2025. No action taken.

AFM Westhart presented the standard financial reports to the Board. Member Grant made a motion to accept the financial reports as presented. Member Shaw seconded the motion. Members voting aye –Shaw, Grant, Knipe, Wilson, and Zaruba.

AFM Westhart asked for any objections or exceptions to the General Consent Items listed under Agenda Item #18.

Approve the previous meeting minutes and dispense with the reading of the same.

- a) Approve monthly compensation of officers, management, and employees as previously fixed by the Board.
- b) Approve, ratify, and allow the following checks, recommended transfers and claims submitted for payment during the month.
- c) Transfer funds from E-W-WW Revenue funds into the checking fund for expenses plus the routine interdepartmental transfers in the amount of \$418,000.00.
- d) Approve the City Free Services Report.
- e) Approve NOD's and Satisfied NOD's as presented.
