## MINUTES OF THE MEETING OF THE BOARD OF PUBLIC WORKS OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA HELD AUGUST 20, 2025

THE BOARD OF PUBLIC WORKS (BPW) OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA, met in regular session on August 20, 2025, at 1600 O Street at 11:30 a.m. This meeting was held in open session as required by Chapter 84, Article 14 of Nebraska State Statutes.

Chairman Knipe called the meeting to order. Roll call: Members present –Shaw, Grant, and Knipe. Absent – Wilson and Zaruba.

Chairman Knipe announced that this was an open meeting, and a copy of the Open Meetings Act is available on the conference table in the Board room.

Member Wilson present at 11:32 a.m.

Chairman Knipe acknowledged the following guest: Joel Kelsay – Property Owner.

Chairman Knipe introduced Joel Kelsay, owner of property at 612 10<sup>th</sup> Street. Kelsay requested reimbursement of cost to install sewer infrastructure at the property. After discussion, the Board determined that during the 2010 sewer project, the Water/Wastewater manager had acted in good faith to contact the property owner and at that time declined connection. The Board communicated there is no cost reimbursement. No action taken.

GM Luhring provided updates on the Westgate addition, our water and electrical portions are near completion and a walk through is scheduled for August 21, 2025. No action taken.

GM luhring presented a master lease agreement from WesTech for pre-clarification equipment rental in the amount of \$281,810.00 for six months in 2026 to be used for the Longs Creek water project. A deposit of \$20,000.00 is required to hold equipment for April 2026 delivery. Freight is subject to change based on actual cost. Member Grant made a motion to enter into agreement as presented. Member Shaw seconded the motion. Members voting aye – Wilson, Shaw, Grant, and Knipe. Motion carried.

GM Luhring presented bids received from Miller & Associates on UV equipment for the water plant. Two bids were reviewed and Luhring recommended a bid from Electric Pump, LLC in the amount of \$149,250.00. After discussion, Member Shaw made a motion to accept the bid as presented, rejecting the bid from Xylem Water solutions USA, Inc. for \$168,180.00. Member Wilson seconded the motion. Members voting aye — Shaw, Grant, Knipe, and Wilson. Motion carried.

Water Wastewater Manager Slater presented information on Drought Contingency Stage 2 water warning. He noted that pumping and static levels of the wells are above normal levels, and rainfall of twenty-seven inches has also exceeded the average year to date amounts of twenty-two inches. W/WW Manager Slater believes that at this time the wells should be able to keep up with normal usage. After discussion, the Board determined that water restrictions should be lifted.

GM Luhring updated the Board on the Longs Creek project noting that all requirements for this stage have been met and we have approval to move forward with the project. The design phase and the UV installation will require approval from the State of Nebraska. Project date for implementation is April 2026. No action taken.

GM Luhring provided an update on the NPPD Capacity Purchase Agreement. The agreement will be presented for approval at the September 17, 2025, BPW Board meeting. No action taken.

GM Luhring provided an update on the 2026 NPPD Wholesale Power Contract. The contract will be presented for approval at the September 27, 2025, BPW Board meeting. No action taken.

GM Luhring presented quotes from Layne Christensen to provide well cleaning and pump inspection for wells 1, 2, 5, 6, 19, and 20. After comparison of quotes, Member Grant made a motion to accept a quote to purchase Wilo pumps for each well and replace as needed during the inspection and cleaning at a cost of \$44,215.00. Member Wilson seconded the motion. Members voting aye – Shaw, Grant, Knipe, and Wilson. Motion carried.

GM Luhring requested permission to submit invitation for bids for a 2024 or 2025 4x4 ½ ton crew cab pickup truck, which will replace a 2005 Chevy ½ ton van. Member Shaw made a motion to move forward with bid requests. Member Grant seconded the motion. Members voting aye – Shaw, Grant, Knipe, and Wilson. Motion carried.

GM Luhring updated the Board of employees that participated in the Nemaha County parade. Appreciation was expressed by the Board. No action taken.

GM Luhring stated that no action is needed on the Personnel Board request.

GM Luhring requested closed session on matters involving personnel and potential litigation. Member Grant made a motion to enter closed session pursuant to Nebraska State Statute at 12:19 p.m. Member Shaw seconded the motion. Members voting aye – Wilson, Shaw, Grant, and Knipe. Motion carried.

Member Grant made a motion to exit closed session at 12:34 p.m. Member Shaw seconded the motion. Members voting aye – Shaw, Grant, Knipe, and Wilson. Motion carried.

AFM Westhart presented the standard financial reports to the Board. Member Grant made a motion to accept the financial reports as presented. Member Shaw seconded the motion. Members voting aye – Grant, Knipe, Wilson, and Shaw. Motion carried.

AFM Westhart asked for any objections or exceptions to the General Consent Items listed under Agenda Item #18.

- a) Approve the previous meeting minutes and dispense with the reading of the same.
- b) Approve monthly compensation of officers, management, and employees as previously fixed by the Board.
- c) Approve, ratify, and allow the following checks, recommended transfers and claims submitted for payment during the month.
- d) Transfer funds from E-W-WW Revenue funds into the checking fund for expenses plus the routine interdepartmental transfers in the amount of \$692,000.00.
- e) Approve the City Free Services Report.
