## MINUTES OF THE MEETING OF THE BOARD OF PUBLIC WORKS OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA HELD OCTOBER 18, 2023

THE BOARD OF PUBLIC WORKS (BPW) OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA, met in regular session on October 18, 2023, at 1600 O Street at the hour of 11:30 a.m. This meeting was held in open session as required by Chapter 84, Article 14 of Nebraska State Statutes.

Chairman Knipe called the meeting to order. Roll call: Members present – Grant, Knipe, and Shaw. Absent – Zaruba and Wilson.

Chairman Knipe announced that this was an open meeting, and a copy of the Open Meetings Act is posted on the northeast wall of the Board room.

Chairman Knipe acknowledged the following guests: Jane Andrew

General Manager Luhring (GM Luhring) requested approval of change order #1 for the Sewer Lining Rehabilitation Project which includes removing a section of the project due to easement issues. A rate change of \$39.00 per linear foot of lined pipe to \$42.00 per foot is reflected as a result of the change. A request for additional time to complete the project was requested by HDR Engineering and Municipal Pipe Tool Co. LLC. An additional five manhole rings and covers will be removed and replaced. The total change results in a decrease of \$64,752.00 from the original contract price of \$624,107.00 to \$559,355.00. Member Grant made a motion to accept the change order as presented. Member Shaw seconded the motion. Members voting aye – Grant, Knipe, and Shaw. Motion carried.

GM Luhring presented the 2024 BPW Electric, Water and Wastewater budgets noting revenues are stable, but industry costs for materials are increasing. GM Luhring recommended a rate study for all departments in 2024 to determine if changes need to be made moving forward. After discussion, Member Grant made a motion to accept the budget as presented. Member Shaw seconded the motion. Member voting aye – Knipe, Shaw, and Grant. Motion carried.

GM Luhring requested purchasing Chamber Bucks to provide each BPW employee a \$25.00 holiday gift. Member Grant made a motion to approve the request. Member Shaw seconded the motion. Members voting aye – Shaw, Grant, and Knipe. Motion carried.

Water/Wastewater Manager Slater provided updates on the Peru water line. The current estimated time frame to start water flowing so they can begin sampling is mid-November. No action.

GM Luhring informed the Board that the BPW Negotiations Committee met and will be meeting with IBEW union representatives October 20th to discuss the 2024 union contract. No action.

GM Luhring noted the 2023 Energy Fest for the Auburn fourth graders is being held October 19<sup>th</sup>. Johnson-Brock students are unable to attend due to changes in their schedule. No action.

GM Luhring requested permission to renew CD's maturing October 29<sup>th</sup>, 2023, at the best available interest rate locally. Member Shaw made a motion to move forward with CD renewals from the highest bidder. Member Grant seconded the motion. Members voting aye – Knipe, Shaw, and Grant. Motion carried.

AFM Westhart presented the standard financial reports to the Board. Member Grant made a motion to accept the financial reports as presented. Member Shaw seconded the motion. Members voting aye – Shaw, Grant, and Knipe. Motion carried.

AFM Westhart asked for any objections or exceptions to the General Consent Items listed under Agenda Item #12.

Approve the previous meeting minutes and dispense with the reading of the same.

- a) Approve monthly compensation of officers, management, and employees as previously fixed by the Board.
- b) Approve, ratify, and allow the following checks, recommended transfers and claims submitted for payment during the month.
